Construction of the 'Neapolis Project' in Limassol

Start date: June 2022

Project Description: A four-storey residential building with 16 modern and stylish apartments of covered area around 2,500m². The building has 6 levels (Ground floor, 1st floor, 2nd floor, 3rd floor, 4th floor and a roof garden). Each of the 4 floors has 4 apartments. The residents of this luxurious project can enjoy a private pool which is located at the roof garden. Part of the façade will feature ELVA aluminium cladding.

Moving towards the completion of the project, works are now concentrated on completing the installation of ELVA aluminium cladding on the facade of the building, completing the painting of the building's exterior and completing the screed works on the ground floor parking area.

As for the works inside the building, the remaining painting works on 4th floor are progressing towards completion. Finally, the electricity supply to the building from the EAC authority is expected to carry out the final Testing & Commissioning works. The project is expected to be completed by the end of April 2025.

Palisandro Hills, Paphos

Start date: September 2022

Project description: A club township consisting of 16 luxurious villas with private swimming pools and their associated road and other external works, including an orchard and a playground. Its design combines a careful attitude towards nature aiming at the same time to create an uncompromisingly comfortable living environment. The general arrangement of the built-up area features two lines of land plots along the valley, making good use of the height difference, recessing the villas located along the valley into the mountain in order to preserve the picturesque panoramic views from the villas situated on the western line.

Palisandro Hills is in Peyia village, Paphos. Its premium location next to a mountain river and a national park guarantees to future residents' spectacular views of the mountains and coastline.

Regarding the progress of works, nine villas are 100% completed (villas 1,2,3,4,5,6,16,17,18). Out of the remaining 7 villas, three villas (villas 7,8 and 15) are 90% completed, two villas (villas 13 and 14) are 80% completed, villa 12 is 70% completed and finally villa 11 is 60% completed.

As for the works concerning the swimming pools, 15 are 100% completed. Regarding villa 11, for which the instructions were sent at a later stage and includes the construction of a swimming pool along with a guest house, the works are 60% completed.

Regarding the external works of the project, all works are concluded. The works included among others, the construction of a Sewage and rainwater collector systems, a Sewerage treatment plant, a EAC substation, curb works associated with the public road and construction of private roads and installation of paving blocks on their surface.

Limassol Greens – Robin West and Robin East Residential Buildings, Limassol

Start date: March 2023

Project description: Limassol Greens is one of the largest master planned developments in the city of Limassol. AECOM, the world's premier infrastructure firm, designed a masterplan that ingeniously sets the residential and commercial units in the centre of the resort development, surrounding them with golf greens and fairways on all sides. Developed over an area of 1.4 million m² Limassol Greens entails an 18-hole championship golf course with a state-of-the-art clubhouse, 500 villas and 250 apartments to be developed in phases, retail and commercial facilities including shops, restaurants, bars, a Wellness Centre with an outdoor pool, spa treatment facilities, fitness area, yoga and meditation lawns, tennis, basketball courts and cycleways, children's playgrounds, an open-air amphitheatre and a herb garden.

The Robin Apartments consist of two blocks, Robin West and Robin East the construction of which is executed by ATLAS PANTOU, set out over a basement, a ground floor and three storeys, served by two separate spacious lobby areas with their own lift. Each apartment block covers around 6,030m² and consists of 26 luxurious 2 and 3-bedroom apartments.

Located in the heart of the resort, within a minute's walk from The Village and The Clubhouse, the Robin Apartment buildings are the only buildings tall enough to enjoy unparalleled views over the Golf Course and up to the Salt Lake, the forest and the sea. The chic and practical interiors combine carefully crafted layouts that work hard to maximise the interior spaces while ensuring the focus remains on the generous terrace and views beyond.

Regarding the progress of the works on the Robin West building, all the external works and the remaining works on the 3rd floor of the building are progressing towards completion. The Robin West building is expected to be delivered by the end of April 2025.

Regarding the works on the Robin East building, finishing works are underway, which include, among other things, carpentry works (installation of parquet, installation of kitchens and cabinets, etc.) and with aluminium works. Externally, the thermal insulation works are in progress. At the same time, the associated external works are also progressing.

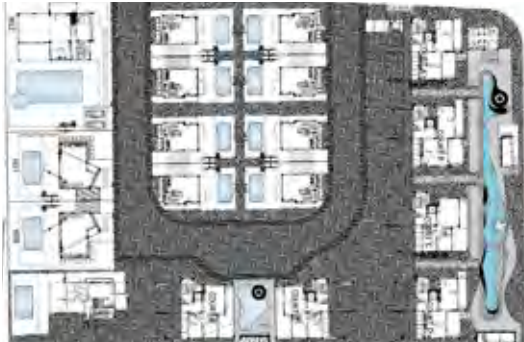

Citrine Estates, Limassol

Start date: January 2024

Project description: Construction of 11 luxurious high-end villas and 7 apartment buildings consisting of 35 one-bedroom and two-bedroom apartments with a covered gross floor area of over 5,500m², along with the associated external works. The external works include private roads with the associated external services such as surface drainage, drainage, electricity & lighting, telephone, water supply and irrigation, construction of sidewalks and swimming pools.

Developed on a private land of around 90,000m² neighbouring the casino-resort City of Dreams Mediterranean, Citrine Estates promises to be a key international destination for luxury living and hotspot for real estate investors. Investors will not only acquire prime real estate, but they also will also acquire unrivalled access to holistic living that delicately combines natural beauty and luxury lifestyle. The project is located amid the majestic Akrotiri Peninsula, allowing residents to revel in the tranquility of nature while surrounded by the abundant birdlife, fragrant orange groves and wild eucalyptus trees that characterize its unique landscape. At the same time, the project's proximity to the city offers easy access to the rich and multicultural lifestyle that has made Limassol the cosmopolitan capital of Cyprus.

Regarding the progress of the works, excavation and backfilling works for the foundations of all the buildings of the Project have long been completed. The structural works of the buildings have also been completed, except for two ceiling slabs of stairwells in two villas.



The structural works, plastering works, and light concrete and screed works have been completed in all apartment buildings (A, B, C, D, E, F, and G). Drywall works (partition walls and false ceilings) are at an advanced stage. Thermal insulation facade works have been completed in apartment buildings A through D (except for the external painting of the 'grafiato' type), and are ongoing in apartment building E. In apartment buildings A through D, windowsills have also been installed, while painting works are ongoing in apartment buildings A and B.

Regarding the progress of the works in the 11 villas, the structural works have been completed in all of them. In villas 1 through 8, plastering works have also been completed, except for villas 5, 6, and 7, which are of the 'shell and core' type and will only be completed externally. Partition wall works have also started in villas 1 through 4.

At the same time, the corresponding electromechanical works for the entire project are progressing. Additionally, elevators have been installed in residential complexes A, B, and C.

Regarding the external works of the project, the structural works for the perimeter walls to the north and west of the development have been completed. The structural works for the swimming pools of villas 1 and 5 through 8 have also been completed. Furthermore, construction works for the smaller auxiliary buildings of the project (changing rooms, mechanical rooms, etc.) have commenced.

The Landmark Nicosia, Marriott Autograph Collection Hotel: Renovation of the Hotel's common Areas and Hotel's external works

Start date: October 2024

Project description: Redefining the essence of timeless hospitality and with a remarkable legacy, the capital's most iconic hotel (formerly the Hilton Cyprus) is undergoing a radical renovation to reopen soon as The Landmark Nicosia, Marriott Autograph Collection and aims to be a premier five-star destination. It is the first hotel unit in Cyprus to join the distinct Autograph Collection hotels of the Marriott group, known for their vision, unique design and hospitality.

As a focal point over the decades, this true landmark of Nicosia features a design that combines the traditional character of the city with the modern architectural trends promising to enhance the area and contribute to the regeneration of Cyprus' capital.

Common areas will include two outdoor and one indoor swimming pool, gardens, tennis court, padel court, fully equipped gym, state-of-the-art spa, two renowned restaurants and high-end boutiques with high-end brands.

To this five-star hotel unit will be added a state-of-the-art 1,400 m2 ballroom, equipped with the latest audio-visual technology, which will provide an ideal environment for social events, meetings, dinners, weddings, conferences and any other type of gathering. This versatile venue will be able to host over 1,000 guests or provide seating for up to 850 people. An additional space of approximately 380 m2 will serve as meeting rooms, ideal for more exclusive gatherings or meetings.



Regarding the progress of the works related to the renovation of the hotel's common areas, demolition works, masonry works, metal construction works and plastering and flooring works (screed) have already been completed. Floor installation and wall cladding works have started, while the construction of false ceilings, waterproofing works, and painting works are ongoing. The electromechanical works are also in progress.

Regarding the progress of the external works, concrete works (planters, water features, etc.) and the construction of an external independent building for the hotel staff have already been completed. Currently the works include the construction of the external services and construction of the external canopies.

Regarding the progress of the works related to the construction of the state-of-the-art Ballroom, masonry works, metal construction works and plastering works have already been completed. Ongoing are the flooring works (screed), waterproofing and ceiling works, and the electromechanical works.

Regarding the progress of the works, the works regarding the basement, the ground floor and the mezzanine are concluded. Currently the works are concentrated on the roof of the extension.

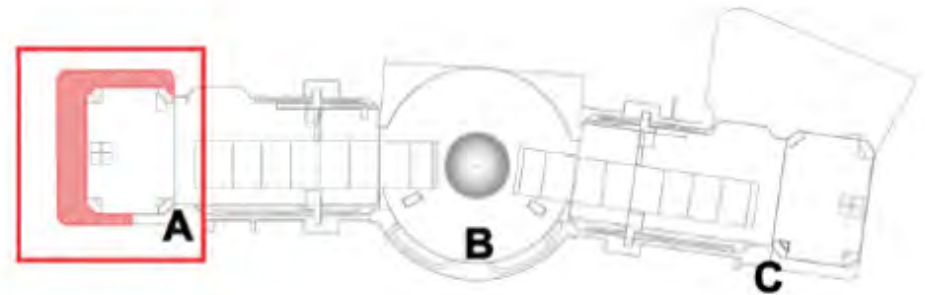

American University of Beirut – Mediterraneo campus, Paphos

Project description: The American University of Beirut (AUB) is one of the MENA (Middle East and North Africa) region's oldest and most prestigious institutions of higher education. The Mediterraneo campus is its first campus outside Lebanon. The project consisted of the construction of campus' Administration building, the Classrooms' building and the Auditorium & Facility building along with the associated external works.

The Administration building is located at the west front side of the plot adjacent to the main access road. It consists of the university administration staff and professors' offices with their services including an entrance lobby, vertical and horizontal circulations, elevators lobby, restrooms, pantries, electric/telecom rooms, a data centre, offices and meeting rooms. The building is distributed on a ground and 3 other floors with an overall gross building area of around 4,270 m².

The Classrooms' building is located at the east back side of the plot. It consists of all the classrooms and spaces related to students with their services including an entrance lobby, vertical and horizontal circulations, elevators lobby, laboratories, study rooms, restrooms, electrical and telecom rooms. The building is distributed on a ground and 3 other floors with an overall gross building area of around 4,850 m².

The Auditorium & Facility building is located adjacent to the Administration building at the south side of the plot. It consists of the campus' facilities and MEP (Mechanical, Electrical and Plumbing) spaces including the Auditorium, a snack bar, water tanks and pump rooms, storages, electrical main rooms, a generator, and maintenance staff offices. The building is distributed on a basement, a ground, and a mezzanine floor with an overall gross building area of around 2,100 m².

The Administration and the Classrooms' buildings is linked with an open colonnade at ground level with an overall gross building area of around 425 m². An electrical sub-station and several storage areas with an overall gross building area of around 230 m² were constructed under the bleachers between the Auditorium & Facility and Classrooms' buildings.

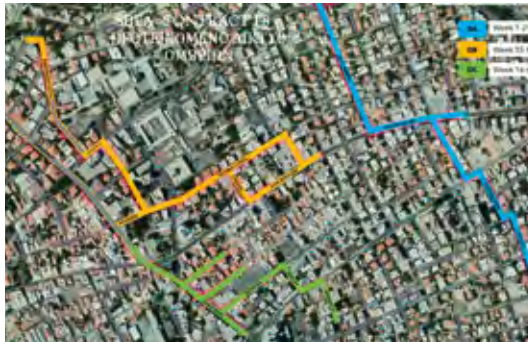


Construction of flood protection works-contract F8, Limassol

Project Description: The project is demarcated south of Makarios Avenue, east of the river Garyllis, west of Agias Zoni Street and north of Gladstonos and Navarinou Streets. The works included the construction of three main collectors for diverting rainwater to the Garylli riverbed. It was a project with an extremely high degree of difficulty, as it consisted of extensive excavation works on 27 streets in the center of Limassol, many of which are main commercial streets with increased traffic and commercial activity.

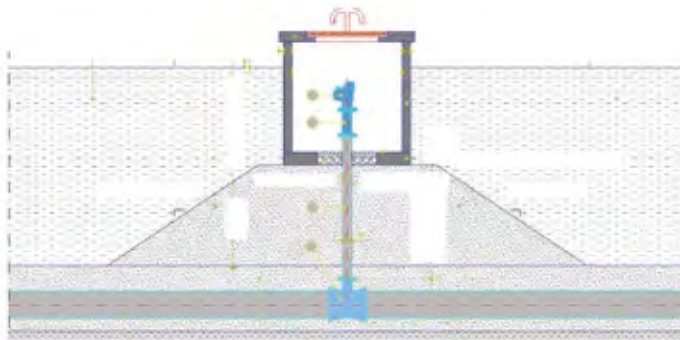
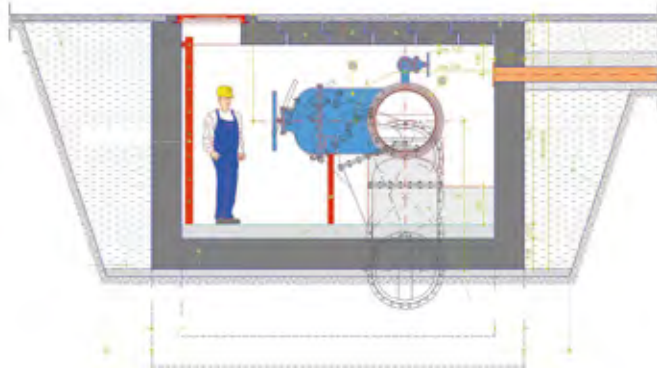
Waterwork Vasilikos – Nicosia, Phase A': Construction of sub-project C1, Pipeline Nisou – Nicosia

Project Description: This important sub-project is part of the large water project Vasilikos-Nicosia and its aim is to transport water from the Vasilikos Desalination Unit to Nicosia. It is the second major source of water supply in the wider Nicosia area.

The creation of the documentary is done with the aim of informing, disseminating, and promoting it throughout the European Union and everywhere in the world, to make known a reality that most certainly ignore.

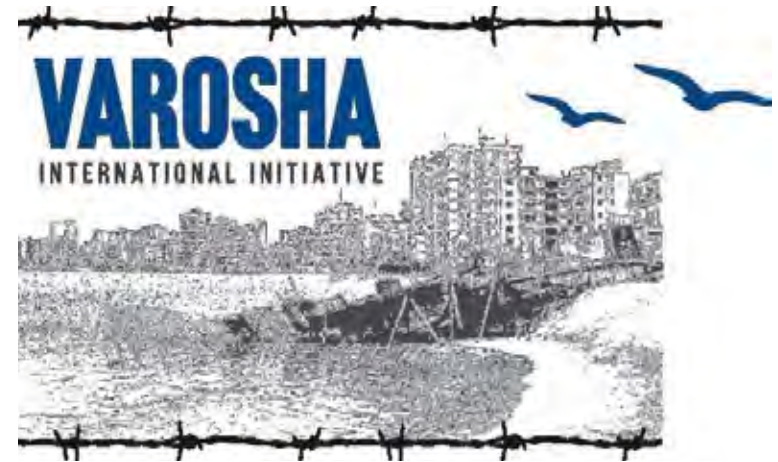

On Saturday, August 31, in the thicket of the Town Hall of Hersonissos in Gournes, the event: "Cyprus 1974-2024. Memory, Debt and Honor" took place. As part of the event, the documentary "Varosha: The walled city of Europe" was screened.

The event was welcomed by the Mayor of Hersonissos, Mr. Zacharias Doxastakis.



The main speaker of the event was the retired Lt. General and former Chief of the National Guard of the Republic of Cyprus, Mr. Dimokritos Zervakis, who, among other things, said: "The wound of the Turkish invasion is still open with visible consequences. The Republic of Cyprus must not be left alone again, as the future of Hellenism is decided there. We are not allowed to forget that the problem of the illegal Turkish invasion and occupation of almost 1/3 of Cyprus remains... Today as we observe Turkey's revisionist attitude, we should urgently continue the necessary actions to realistically deal with the continuous evolving Turkish provocation with which vital interests of Hellenism are affected".

Mr. Tonis Toumazis, founder of the non-profit initiative 'Varosha International Initiative', prior to the documentary screening, briefly referred to the reasons behind his initiative to create this documentary for Varosha.

The man behind the documentary "Varosha: Europe's Enclosed Town", which aims to raise awareness and awaken the international community to the issue of the enclosed city of Varosha in Cyprus, Mr. Tonis Toumazis granted an interview to Thema Crete 103.1 and Maria Yamboulaki.

Maria Yamboulaki writes:

Mr. Tonis Toumazis referred to the history of the people of Varosha, the timeless requests of the people who to this day cannot return to their properties, the ignorance that Europeans have around this issue and the need to raise awareness, be informed and then for the society itself to claim the implementation of the decisions that have been taken, the implementation of the law.

Varosha, a district of Famagusta, Cyprus, used to be a lively and thriving seaside holiday resort, famous for its golden sands and for attracting tourists and celebrities from all over the world. This documentary delves into how Warsaw came to a sudden halt overnight after the Turkish invasion and is still, to this day, an ongoing occupation.

The Varosha Initiative was founded in 2023 by Mr. Tonis Toumazis based on the belief that public opinion can influence policy making to act in accordance with international law and UN resolutions resulting in the return of the city of Varosha to their inhabitants.

It is important to mention that since 1984 there have been resolutions of the United Nations Security Council on Varosha, according to which attempts to colonize any part of Varosha by people other than its residents are unacceptable.

In 2021, on the provocations of the Turkish President, the Council of the European Union in a relevant press release issued word-by-word the following:

"The EU continues to act on the basis of the relevant UN Security Council resolutions on Varosha, in particular resolutions 550 (1984) and 789 (1992), according to which attempts to settle any part of Varosha by persons other than their inhabitants are unacceptable. In fact, the decisions call for the administration of the region to be transferred to the United Nations. No action should be taken in relation to Varosha that is inconsistent with the above decisions. For the full observance and implementation of the decisions of the UN Security Council, the immediate termination of the restrictions imposed on the free movement of the UN Peacekeeping Force in Cyprus (UNFICYP) in the Varosha area is also required. The EU continues to hold the government of Turkey responsible for the situation in the enclosed city of Varosha."

What one can reasonably ask is how much power does the United Nations have after all these years when the decisions of the Security Council have not been implemented? How much political power does the EU have when it publicly condemns specific acts but is unable to enforce the law?

The discussion was moderated by journalist, founder of Danezis Stories, Sotiris Danezis.

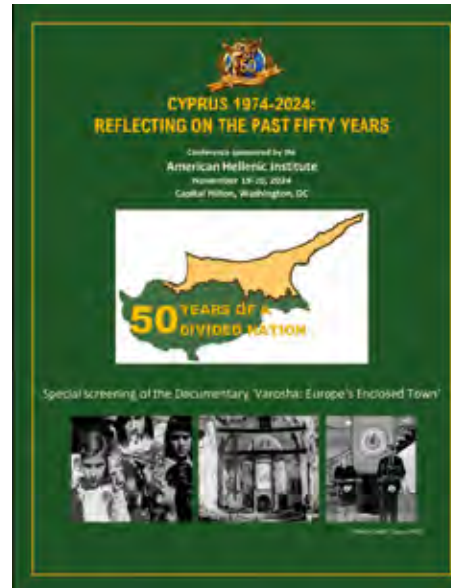

As part of the ongoing efforts of the 'International Initiative for Varosha', led by its Founder Mr. Tonis Toumazis, to raise awareness and disseminate information on the unacceptable situation of the enclosed city of Varosha, on Thursday, November 21st, 2024, the documentary 'Varosha Europe's Enclosed Town' was screened at the "Thespis" Theater of the Hellenic Cultural Center in Astoria, New York. The screening was organized by the Pancyprian Association of America.

Demetris Tsakas writes:

The screening of the documentary "Varosha European fenced-off city" touched the hearts of the expatriates and sparked the dialogue.

The screening was organized by the Pancyprian Association of America on the evening of Thursday, November 21st, 2024, at the "Thespis" Theatre of the Hellenic Cultural Center in Astoria, New York, where the producer Mr. Tonis Toumazis was present together with his son. The atmosphere from the beginning until the end of the screening was strongly charged.

The documentary was prefaced by the choir of the Pancyprian Association, which, under the direction of maestro Phytos Stratis, performed songs dedicated to the dramatic fate of the walled city and its inhabitants, who for half a century have been waiting for the time to return to their ancestral homes. Varosha, more widely known as 'the ghost town', groaned for half a century under the boot of Attila, as none of its inhabitants can visit their homes.

The presentation was undertaken by the artistic director of the Hellenic Cultural Center, Alexandros Famaghostianos, who welcomed the attendees and the producer Mr. Tonis Toumazis, who travelled from Cyprus for the screening, and expressed his gratitude towards the Pancyprian Association and the Federation of Cypriot Organizations who collaborated for the screening of the documentary.

Mr. Toumazis was presented by the president of the Pancyprian Association, Mr. Philip Christopher, who emphasized that the fate of all refugees from the Occupied Territories is common and explained that no matter how many years pass, the burning desire and dream of returning to Kyrenia does not fade. Mr. Toumazis pointed out that in Europe, but even in Greece and Cyprus, people do not know about the fenced off city of Varosha and the ongoing suffering of people who cannot return to their homes, even though two UN resolutions have been issued, resolutions that Turkey still ignores.

He also emphasized that leaving people's houses to rot, forbidding residents to return, and not making use of the fenced off city, constitute "sadism" on the part of Turkey.

The documentary focuses on the situation in Varosha, which as he says, "is unacceptable and maybe some people with the power can do something about it."

At the same time, he explained that since the Republic of Cyprus is a member of the European Union, the city of Varosha is the only fenced off European 'ghost town'.

Mr. Toumazis donated books to the Organizers of the event and invited expatriates to promote the documentary which is available for free viewing through the website varoshaeu.com.

Foreword by Mr. Tonis Toumazis, Founder of ATLAS PANTOU and ATLAS PANTON groups

From cave dwelling to the first stone and timber structures, from clay to concrete and iron, man has not stopped evolving. Once, in the distant past, we gazed at the skyline from the port of ancient Salamis. Today we gaze at it from the balconies of skyscrapers, watching merchant ships, cruise ships, and hydrocarbon mining platforms plough the seas of our island.

As a businessman and civil engineer, I have always admired the art and science of building. We lost Famagusta and our properties, yet we never lost the courage to continue, nor the ability to maintain the development of our expertise. After taking over the management of the company in 1987, with consistency, persistence and immeasurable hard work from all the personnel, we managed to transform the company into a highly regarded and well-respected group by the name of Atlas Pantou.

From prehistoric times to the present, the building techniques that have been adopted in Cyprus have played a major role in the development of our quality of life; they have contributed to the local population's survival, evolution and progress, even shaping our culture.

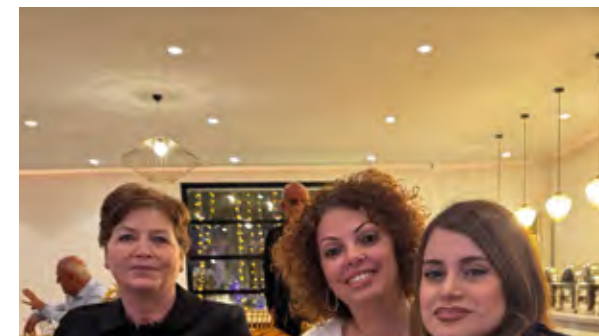
